AUTHORIZATION FOR IRA TRANSFERS, DIRECT ROLLOVER & CONVERSIONS

You may use this form to effect a direct transfer from an existing IRA with another custodian to an IRA with Baron Capital®, a direct rollover from an employer-sponsored qualified plan or 403(b) account to an IRA, a conversion from a Traditional IRA to a Roth IRA or a re-characterization from a Roth IRA to another type of IRA. The assets may be from another fund family or within Baron Capital®. **Note**: If you are a new client (not transfering money into an existing account) please fill out an IRA Application as well.
