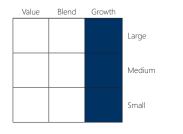

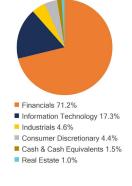

### Investment Strategy

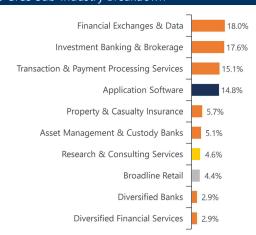
